Terms and Conditions - Promotions and Contests

I. PROMOTION

120 (the "**Promoter**") will be running a competition from June 17, 2024 to 12:00AM on September 29, 2024 inclusive (the "**Competition**"). Users are invited to participate for the chance to win throughout the duration of the Competition.

To take part and for the chance to win, participants must enter their details and register to the 120 database via the QR code and www.120horas.com. There will be a total of one (1) winner who will receive one (1) prize, details of which are set out in Part IV below (the "**Prize**").

II. ENTRY INSTRUCTIONS

In order to enter the Competition, participants must first register their details via our landing page.

Participants must fill in all required fields, including: user name, e-mail, phone number, date of birth and country from which they are participating.

On entering this data, participants will be entered into a draw to win the Prize.

The promotion is only open to residents of Ireland aged 18 years or over.

All entries must be received by the Promoter by no later than midnight on the 29 of September, 2024. All competition entries received after this date are automatically disqualified.

III. EXCLUSIONS FROM PARTICIPATION

The following are not eligible to participate in this promotion:

- Persons who are not a resident of Ireland; and
- Any person who has participated directly or indirectly in the preparation of these terms and conditions.
